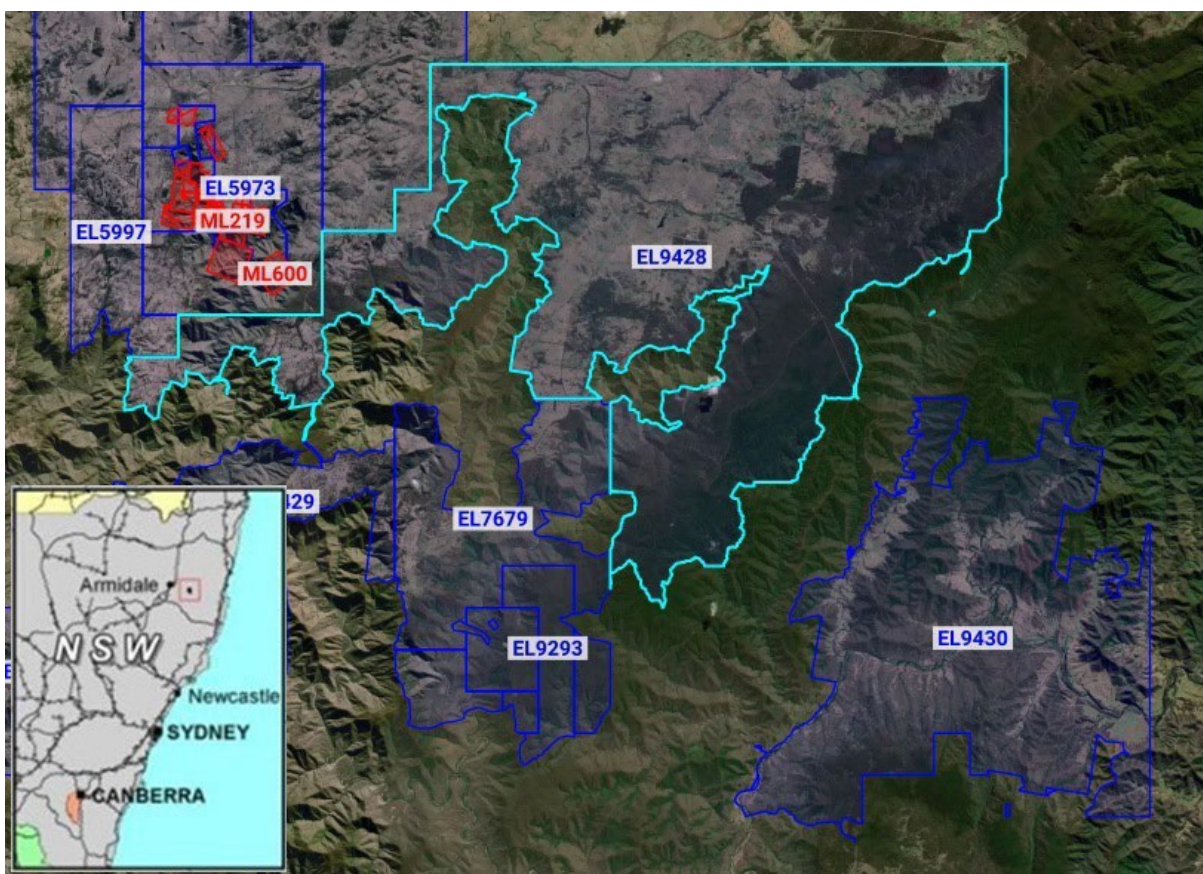


Figure 1: Location of EL 9428 and the Halls Peak Project Area.

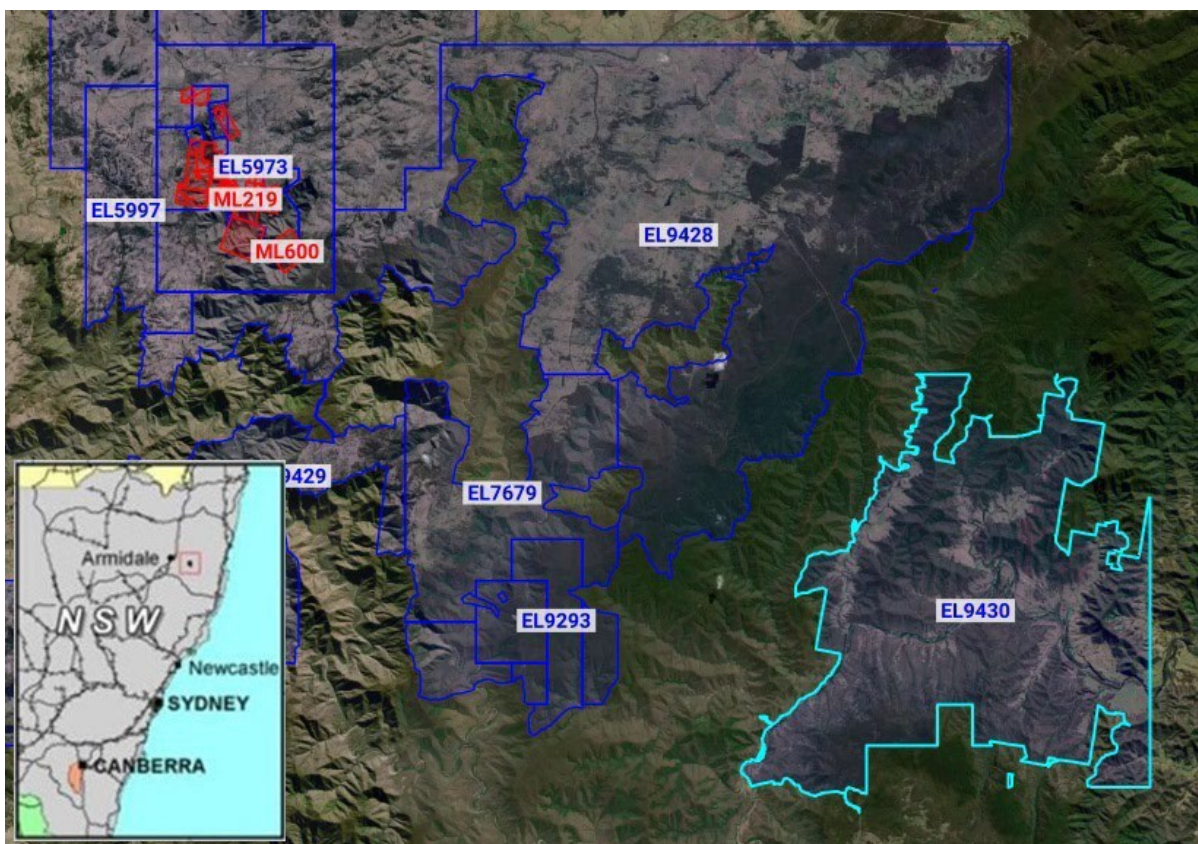


Figure 1: Location of EL 9430 and the Halls Peak Project Area.

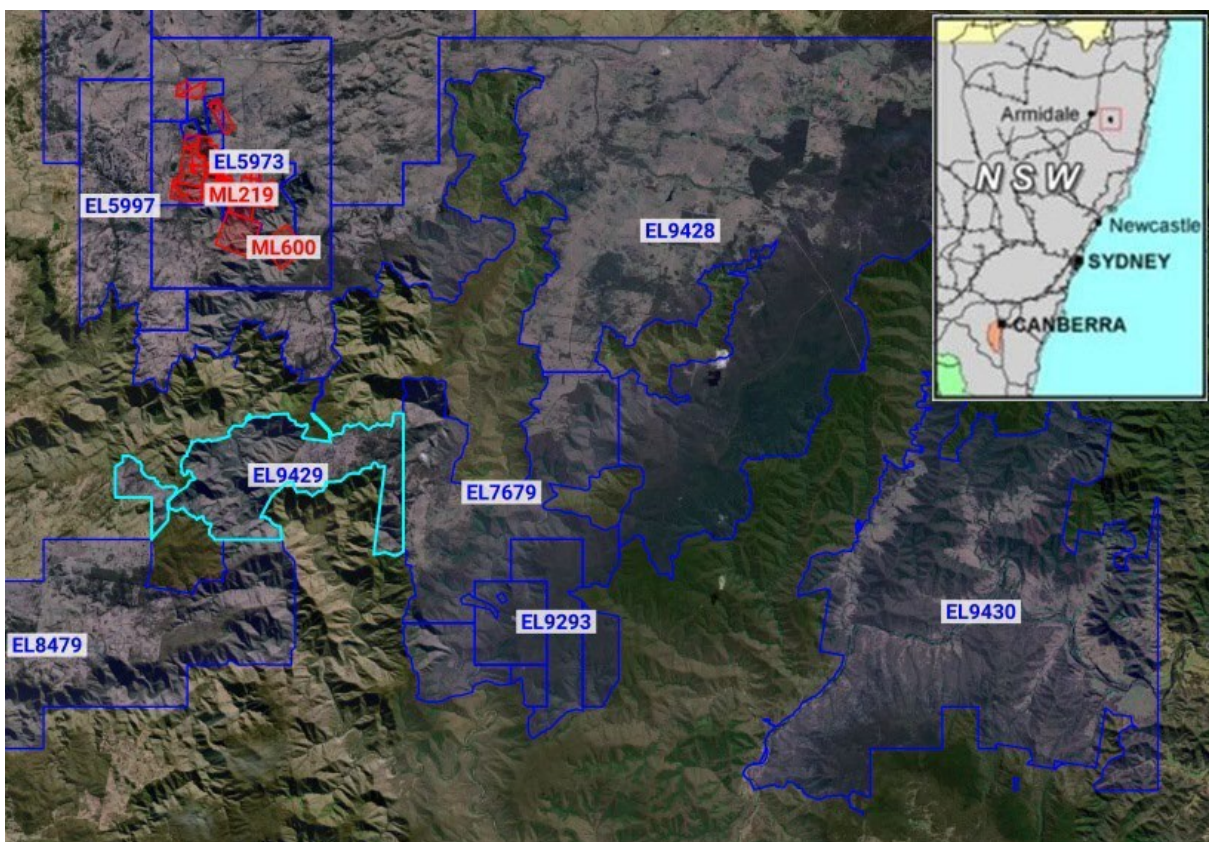


Figure 1: Location of EL 9429 and the Halls Peak Project Area.

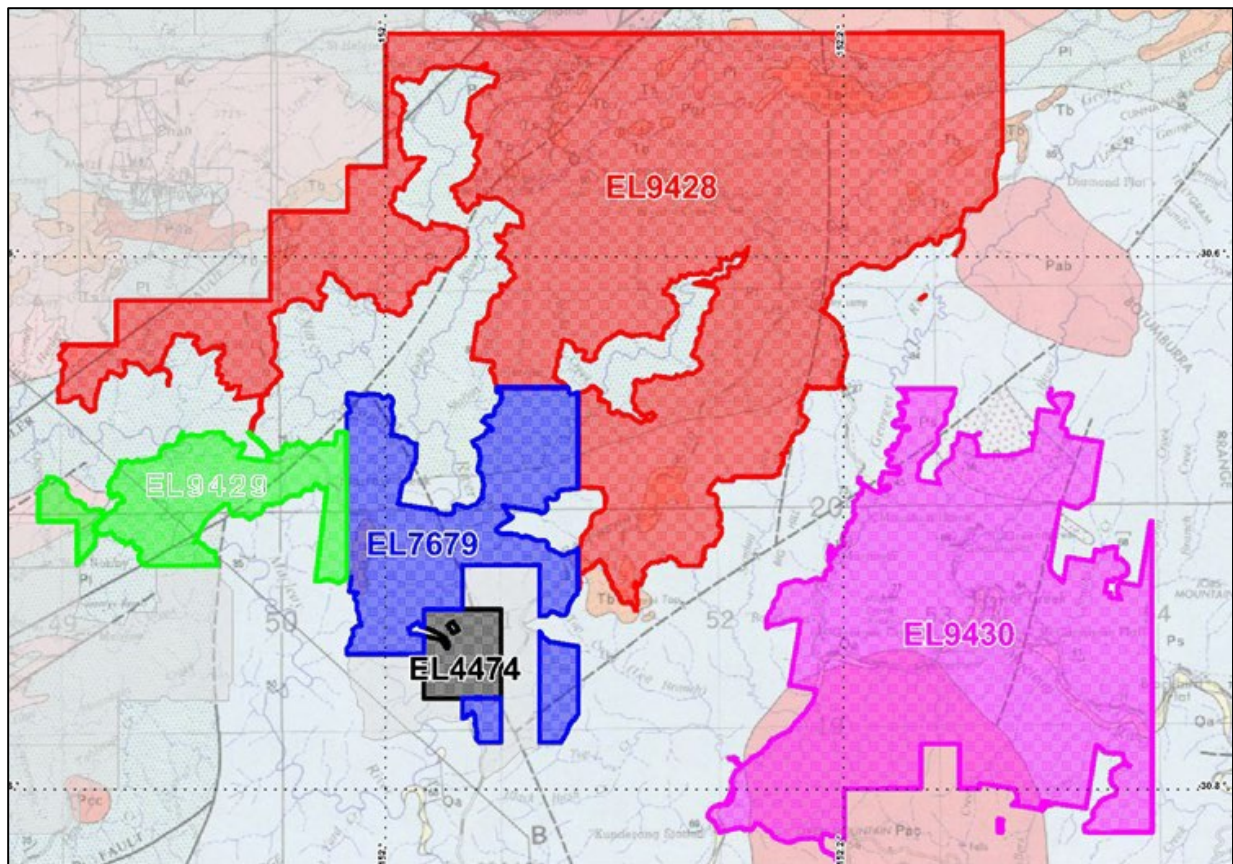


Figure 1: Location of EL 4474 and the Halls Peak Project Area.

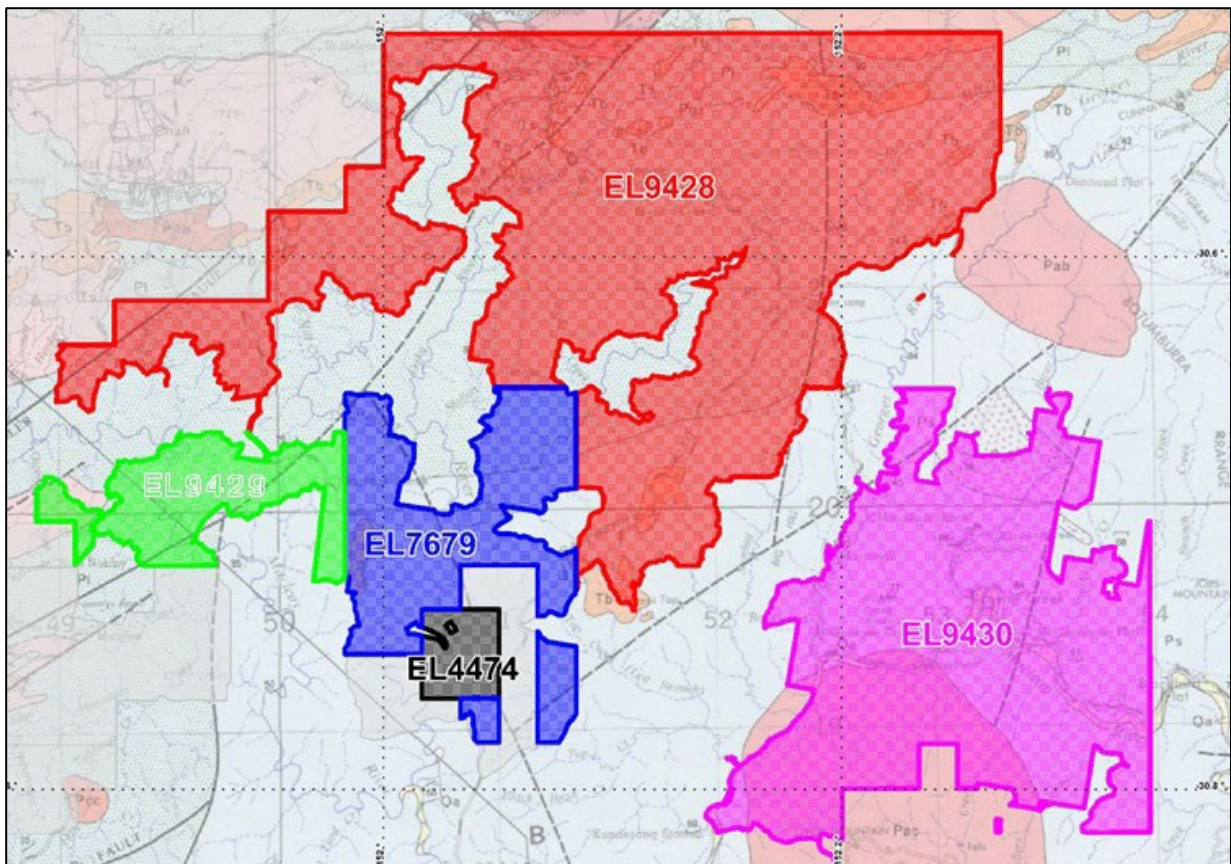


Figure 1: Location of EL 7679 and the Halls Peak Project Area.
